Dear Ms. Darby:

According to local utility officials, the Lakes at Madison Park site located near Vista Street in St. Tammany Parish, Louisiana does not have an existing natural gas line on site. A natural gas distribution line operated by the Town of Madisonville exists west of the site and is available for natural gas access.

In order to provide a natural gas supply, the site would require the construction of a 150 linear foot (L.F.) service connection to tie in to the Town of Madisonville gas line. The construction cost of a proposed 2" natural gas line capable of providing service to the site is estimated to be \$12,000. Permission would have to be granted from the Town of Madisonville to tie in to their distribution line. A servitude is available from the adjacent subdivision for gas access. The proposed line does not cross any parcels prior to reaching the Lakes at Madison Park site.

Please note this estimate does not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. The actual costs can vary based on the availability of material, site conditions and labor availability. This plan can be executed within a reasonable timetable of 180 days or less based on preliminary engineering judgment.





Town of Madisonville New 8" High Pressure Gas Pipeline – LA Hwy. 1077 *

General Background

The Town of Madisonville serves 3,586 natural gas customers via a network of distribution lines which vary in size. The Town's main natural gas purchase point for distribution is from a high pressure transmission line located just north of U.S. Hwy. 190 in Goodbee, Louisiana.

Through the current pipeline network, natural gas is conveyed via a 4" diameter pipeline from its purchase point north of U.S. 190 to the southern reaches of the system approximately six miles along LA Hwy. 1077. The system demand has been growing at an accelerated pace due to the large amount of construction in the service area.

Computer modeling of the distribution system revealed that a larger pipeline would be needed to convey the required volume while maintaining the pressures at an adequate level along the LA Hwy. 1077 corridor.

The project is divided into three phases:

- Phase 1: Relocation of the existing line at a newly configured intersection of LA Hwy. 1077 and LA Hwy. 1085.
- Phase 2: Upsizing the pipeline from 4" to 8" in diameter along LA Hwy. 1077 from LA Hwy. 1085 to the purchase point north of U.S. Hwy. 190
- Phase 3: Upsizing the existing pipeline from 4" to 8" in diameter from LA Hwy. 1085 south approximately 13,000 feet.
