Dear Mr. Cavanaugh:

A proposed cost estimate is outlined below for the construction of a railroad spur to access the Angel Ranch Site in Pointe Coupee Parish, Louisiana. The proposed rail spur will connect directly to an existing rail line owned by Big Cajun II, pass under an overpass and extend through seven properties before servicing the Angel Ranch site. This would require negotiating an agreement with Big Cajun II to connect to their rail line. The clearance and design requirements to pass the rail line under the overpass must be verified prior to construction. The construction cost of a railroad spur, which includes labor, materials (switches, frogs, ballast, and track), and fill is estimated to be \$300 per linear foot (L.F). The total track length of the proposed spur is approximately 5,000 L.F yielding a total estimated construction cost of \$1,500,000.

Please note this estimate does not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. The actual costs can vary based on the availability of material, site conditions and labor availability. This plan can be executed within a reasonable timetable of 180 days or less based on preliminary engineering judgment and Kansas City Southern Railroad construction guidelines.



Pointe Coupee Parish, LA




