Dear Mr. Cavanaugh:

According to correspondence with local utility officials, the Gateway II Site located on LA 30 between LA 73 and LA 3115 does not have access to an existing potable/process water line to service the site. The water utilities in this area are managed by Ascension Water Company. The nearest elevated potable water storage tank has a capacity of 1,000,000 gallons and is located on Outfitter's Drive near the intersection of LA 30 and I-10. However, no infrastructure exists to allow access to this tank. Adjacent area businesses draw their water from onsite wells, but in our communication with local well drilling contractors the water quality from these wells is of poor quality and would require pretreatment before use as reliable potable water.

In order to provide adequate potable water supply to the site a water line would need to be constructed to connect to the existing 12" water feed line at the intersection of Hwy 73 and Hwy 30 approximately 8,000' southeast of the site. The cost to build this connection would be approximately \$1,013,140 and includes the water main pipe, casing, connection to the existing water line, gate valves and hydrants.

In order to provide process water supply to the site a well can be drilled. The cost of a new well to provide 250,000 gallons per day is estimated to be \$500,000 plus \$20 per linear foot of pipe for the water line.

Please note that this estimate does not include engineering, rights of way acquisition, environmental impacts and permitting or operation and maintenance costs. In addition, these costs can vary depending on material and labor availability. This plan can be executed within a reasonable timetable of 180 days based on preliminary engineering judgment.




