



Dear Mr. Lafonte:

According to local utility officials, the site located in Terrebonne Parish, Louisiana has access to a 2" natural gas line near the site. This does not meet the LED's minimum requirement of a 4" natural gas line being available to the site. A natural gas transmission line operated by Bridgeline Holdings exists to the North of the site that may be available for natural gas access. In order to provide an adequate natural gas supply to the site, a tap and metering station will need to be constructed.

CSRS contacted Bridgeline Holdings and determined that a tap and metering station off their pipeline is feasible. Exact location of the tapping station will need to be determined by the provider based on needed capacity and the location of the proposed site pad. The construction cost of a natural gas tapping station and 8,770 feet of 4" distribution line to reach the site is estimated to be \$914,000. The proposed line could be installed within the right of way of Louisiana Highway 311 to avoid the creation of additional right of way.


Please note this estimate does not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. The actual costs can vary based on the availability of material, site conditions and labor availability. This plan can be executed within a reasonable timetable of 6 months or less based on preliminary engineering judgment.
