

## Exhibit D. Allstar Site Noise Level Restrictions

### Sec. 58-4. - Loud and unusual noises.

(a) *Prohibited.* It shall be unlawful for any person to make, continue or cause to be made or continued any loud noise which disturbs, injures or endangers the comfort, repose, health, peace or safety of others in the unincorporated areas of the parish, as hereinafter set forth.

(b) *Noises enumerated.* The following noises are declared to be unreasonable:

(1) Any unreasonably loud, disturbing noise which causes material distress, discomfort or injury to persons of ordinary sensibilities in the immediate vicinity thereof is hereby declared to be a nuisance and is hereby prohibited.

(2) Any noise of such character, intensity and continued duration which substantially interferes with the comfortable enjoyment of private homes by persons of ordinary sensibilities is hereby declared to be a nuisance and is hereby prohibited.

(3) The following acts are declared to be nuisances in violation of this section:

a. *Musical instruments.* The playing of any radio, phonograph, or other musical instrument in such manner or with such volume, particularly during the hours between 10:00 p.m. and 7:00 a.m., as to annoy or disturb the quiet, comfort, or repose of persons of ordinary sensibilities in any dwelling, hotel or other type of residence.

b. *Animals and birds.* The keeping of any animal or bird which, by causing frequent or long-continued noise, shall disturb the comfort and repose of any person of ordinary sensibilities in the immediate vicinity.

c. *Horns or other signal devices on vehicles.* The continued or frequent sounding of any horn or signal device on any automobile, motorcycle, bus, or other vehicle, except as a danger or warning signal; the creation by means of any such signal device of any unreasonably loud or harsh sound for any unreasonable period of time.

d. *Operation of vehicles.* The running of any automobile, motorcycle, or other vehicle so out of repair, so loaded or in such manner as to create loud grating, grinding, jarring or rattling noises or vibrations.

e. *Steam whistles.* The blowing of any steam whistle attached to any stationary boiler, except to give notice of the time to begin or stop work or as a warning of danger.

f. *Exhaust without muffler.* The discharge into the open air of the exhaust of any steam engine, stationary internal combustion engine, motor vehicle or boat engine, upon public roads/streets, except through a muffler or other device which will effectively prevent loud or explosive noises therefrom.

g. *Devices operated by compressed air.* The use of any mechanical device operated by compressed air, unless the noise to be created is effectively muffled and reduced.

h. *Construction work.* The erection, excavation, demolition, alteration, or repair work on any building whereby loud and annoying noises are created, other than between the hours of 7:00 a.m. and 6:00 p.m. on weekdays, except in case of urgent necessity in the interest of public safety and convenience and then only by permit from the parish president or his designee, which permit may be renewed by the parish president or his designee during the time the emergency exists.

i. *Near schools and hospitals.* The creation of any excessive noise on any street adjacent to any school or institution of learning while the same is in session or adjacent to any hospital or nursing home which unreasonably interferes with the working of such institutions, provided conspicuous signs are displayed in such manner indicating that the same is a school, hospital, or nursing home street.

j. *Loading and unloading vehicles, etc.* The creation of any loud and excessive noise in connection with the loading or unloading of any vehicle or the opening and destruction of bales, boxes, crates, and containers.

k. *Peddlers, hawkers, etc.* The raucous shouting and crying of peddlers, hawkers, and vendors which disturbs the peace and quiet of the neighborhood.

l. *Sounding of sirens, etc., on vehicles.* The sounding of any siren, horn, or other signal device on any automobile, ambulance, truck, motorcycle, bus or other vehicle in the unincorporated areas of the parish, except as a danger or warning signal to persons or animals using the streets, sidewalks, and public thoroughfares, shall constitute a violation of this section.

(c) *Penalty.* Any person found guilty of violating provisions of this section shall be subject to a fine of not less than \$100.00, but not more than \$500.00 or imprisonment not to exceed 30 days, or both. Upon a subsequent violation, regardless of whether the second offense occurred before or after the first conviction, the offender shall be imprisoned for not less than five days or not to exceed six months, or fined not less than \$250.00, but not more than \$500.00, or both.
