

## Noel Site, Ascension Parish - Dock Feasibility Technical Memo

The following technical memo provides a detailed summary outlining the feedback received from review of the Noel Site in Ascension Parish, LA during the NOBRA/MNSA board meeting held on October 27th, 2021. Conceptual dock layouts were developed with associated deep draft ship (650'x100') locations for each candidate site that can be reference in Attachment A.

### **Site Characteristics**

Total Site Acreage: 930 acres +/-

- **Batture**: 90 acres +/-

River Frontage: 3,265 linear feet +/Nearest River Mile Marker: 184

### **Overview**


- The Noel Site is located in Ascension Parish, Louisiana and it within Philadelphia Point.
- For general reference, the site is located along the Mississippi River Mile Marker 184.
- The conceptual dock shown in **Attachment A** was located along the southern section of the site and reaches the USACE river survey depth of approximately 20-ft. CSRS prepare a conceptual dredge area to represent the area that would likely require periodic dredging to support deep draft access.
- The location of the dock along the 20-ft contour line was strategically sited to be far enough away from the 500-ft wide navigable channel to not present a known navigational issue with deep draft and barging transportation.

## Considerations for continued dock feasibility determination

- To support deep draft access at the proposed dock location, continued dredging and maintenance activities will likely be required.
- Feedback from the MNSA board confirm that the site is located far enough upriver to avoid any restrictions with the downriver Philadelphia Point Crossing and restricted anchorage area due to several pipeline crossings.
- It was noted that dredging of a dock site can create an unnatural bowl along the River bottom that can create a "vacuum/suction" to moored ships when other ships in transit pass. This constraint would likely not pose a major risk due to the distance away from the 500-ft wide navigable channel.



# Noel Site Mississippi River Depth




