Dear Mr. Henson:

Subsequent to our discussions with Union Pacific and Cargill, Inc. we have determined the Bridgeview Park Site located in Jefferson Parish is adjacent to a Union Pacific rail line currently leased by Cargill, Inc. In order to provide rail access to the Bridgeview Park Site, the site user will first need to successfully negotiate a commercial sub-lease agreement directly with Cargill, Inc.

Cargill advised while they are open to sub-leasing, the potential lease agreement will depend on numerous variables including:

- Type of Industry. Ideally, Cargill, Inc. would like a user that does not compete directly with Cargill, Inc.
- Number and frequency of incoming and outgoing rail cars per day
- Times of day rail access is needed

Rail service to the site will require redesign and upgrading the existing rail corridor to meet the current demands of the existing users and a new rail spur to service the proposed site.

The new corridor design will need to address the existing conditions and concerns:

- Installation of a new switch in between LA Hwy 18 and the existing switch to service the proposed site
- Realignment of a portion of the existing Cargill, Inc. rail track to maintain existing level of service
- Removal of approximately 300 linear feet of the existing Cargill, Inc. rail track

The construction cost of a railroad spur for this option, which includes labor, materials (switches, frogs, ballast, and track), is estimated to be \$1,250,000 - \$1,450,000. This does not include monetary considerations that may be required to secure the lease agreement with Cargill, Inc.

Please note these estimates do not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. The actual costs can vary based on the availability of material, specific site conditions, final design, and labor availability. These plans can be executed within a reasonable timetable of 24 months or less based on preliminary engineering judgment, correspondence with Union Pacific representatives, and Union Pacific construction guidelines.


