La Division of Archaeology Report No. 22-6735

*Phase I Cultural Resources Survey of 63 acres (25.4 hectares) near Broussard, Lafayette Parish, Louisiana*

Dear Sally McMillan:

We acknowledge receipt of your letter dated 31 March 2021 and one copy of the above referenced report that was submitted as Due Diligence. This letter is for preliminary, informational purposes only and does not constitute consultation or agency coordination with our Office as defined in 36 CFR 800: "Protection of Historic Properties" or by any state regulatory process. The recommendation stated below could change once the responsible federal and/or state agency initiates consultation with our Office.

If the proposed project were to require federal permits, licenses, funds, loans, grants, or assistance for development, we would recommend to the federal or state agency or agencies that sites 16LY155 and 16LY156 are not eligible for nomination to the National Register of Historic Places. We also concur that Structure 50-00789 is not eligible for nomination to the National Register, and that no historic properties will be affected by this undertaking. Our office has no further concerns for this project.

Consultation with the State Historic Preservation Office does not constitute consultation with Tribal Historic Preservation Offices, other Native American tribes, local governments, or the public. If archaeological materials are encountered during construction, the procedures codified at 36 CFR 800.13(b) will apply. Archaeological materials consist of any items, fifty years old or older, which were made or used by man. These items include but are not limited to, stone projectile points (arrowheads), ceramic sherds, bricks, worked wood, bone and stone, metal, and glass objects. The federal agency or the applicant receiving federal assistance should contact our office immediately. If human remains are encountered, the provisions of the Louisiana Unmarked Human Burial Sites Preservation Act (Revised Statute 8:671-681) should be followed.
