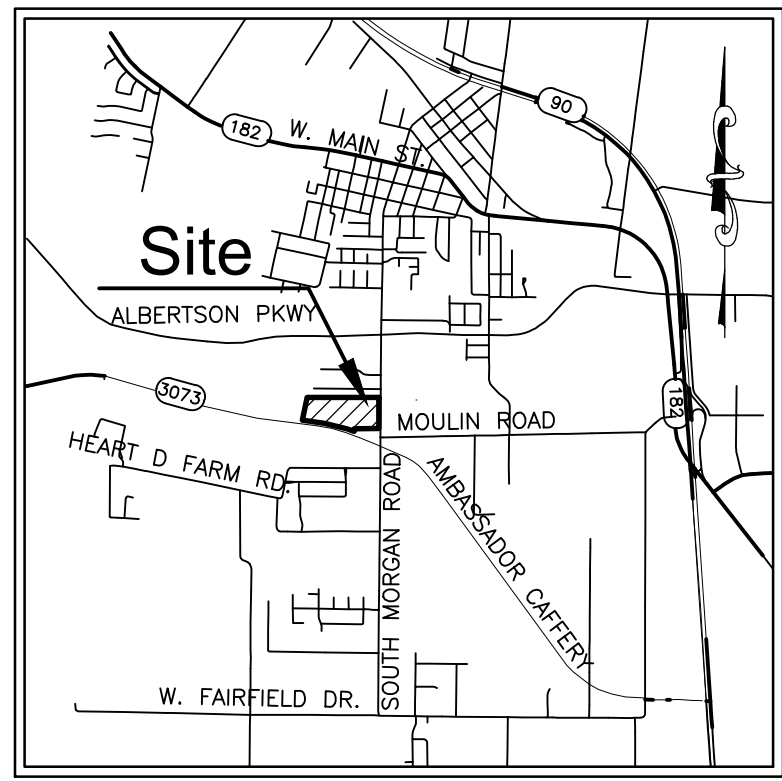

# SOUTH MORGAN SITE PROPERTY RIGHT OF WAY EXHIBIT

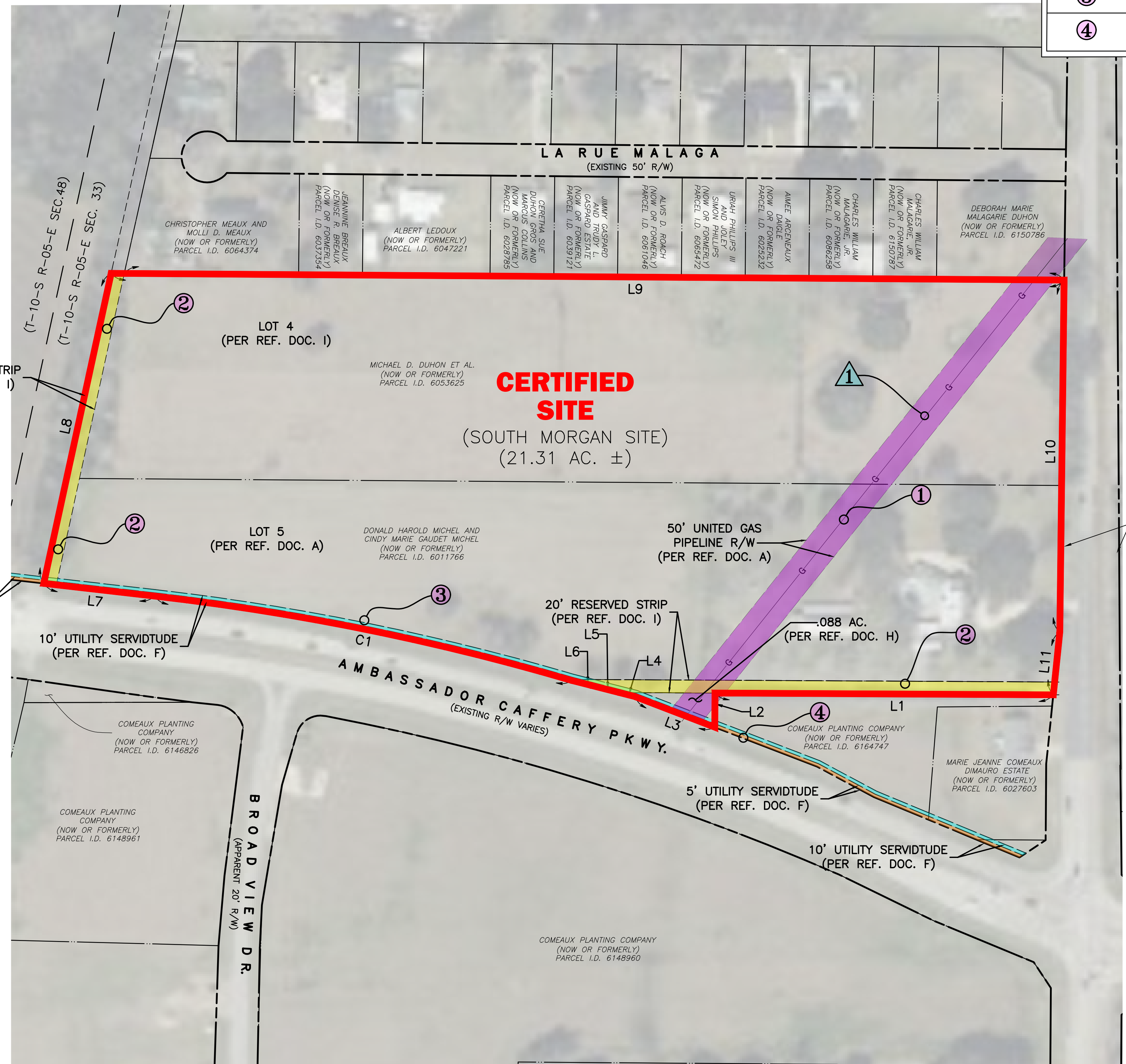


VICINITY MAP

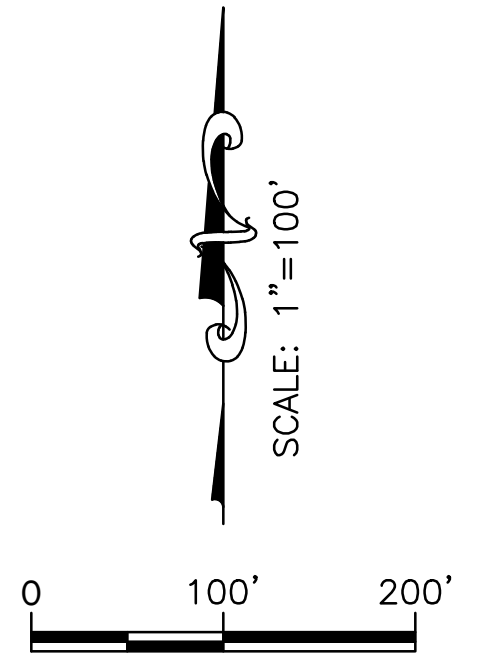
