According to the FEMA Digital Flood Insurance Rate Map (DFIRM) panel no. 2250275C of St. Tammany Parish, Louisiana, effective October 17, 1989, the Tamanend Business Park West property is located in Flood Zone "C". In addition, according to the FEMA Effective DFIRM map provided on the LSU AgCenter website (<http://maps.lsuagcenter.com>), the site is located in Flood Zone "X". The LiDAR contours downloaded from LSU's ATLAS site indicate that the site ranges in elevation from 28 feet to 31 feet, however, the mean elevation of the developable property on the site is at elevation 29 feet.

No further action is needed to meet floodplain construction standards.


