Dear Mr. Hager:

According to local utility officials, the North Park site located in Lafayette Parish, Louisiana does not have access to an existing natural gas line to service the site. A natural gas distribution line operated by Atmos Energy exists east of the site and may be available for natural gas access.

In order to provide a natural gas supply, the site would require the construction of a 418.50 linear foot (L.F.) service connection to tie in to the Atmos Energy Distribution gas line. The construction cost of a proposed 4" natural gas line capable of providing service to the site is estimated to be \$16,740.00. Permission would have to be granted from Atmos Energy to tie in to their distribution line. Also, servitudes would have to be obtained from the land owners of the proposed pipeline's path. The proposed line crosses one parcel prior to reaching the North Park site.

Please note this estimate does not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. The actual costs can vary based on the availability of material, site conditions and labor availability. This plan can be executed within a reasonable timetable of 18 months or less based on preliminary engineering judgment.


