

A proposed cost estimate is outlined below for the construction of a railroad spur to access the Spanish Trail Industrial Park in St. Martin Parish, Louisiana. The proposed rail spur will connect directly to an existing BNSF Railway line. The construction cost of a railroad spur, which includes labor, materials, and fill is estimated to be \$1,584,000.


Please note this estimate does not include engineering, required rights of way, environmental impacts, or operation and maintenance costs. This cost estimate was prepared with the best information available at the time of certification. This plan can be executed within a reasonable timetable of 18 months or less based on preliminary engineering judgment and Burlington Northern Santa Fe Rail Line Railroad construction guidelines.
