Reference is made to your request, on behalf of Reimers Company, LLC, for a U.S. Army Corps of Engineers' jurisdictional determination on property located in Section 25, Township 6 South, Range 9 East, Tangipahoa Parish, Louisiana (enclosed map). Specifically, the property identified as the I-12 Industrial Site in Robert.

A field inspection of the property was conducted on February 19, 2019. Based on the results of this investigation and the information submitted with your application, we have determined that part of the property contains wetlands and non-wetland waters that may be subject to Corps' jurisdiction. The approximate limits of the wetland and non-wetland waters are designated in red and blue, respectively, on the map. A Department of the Army permit under Section 404 of the Clean Water Act will be required prior to the deposition or redistribution of dredged or fill material into waters of the U.S., including wetlands.

You are advised that this preliminary jurisdictional determination is valid for a period of 5 years from the date of this letter unless new information warrants revision prior to the expiration date or the District Commander has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.


