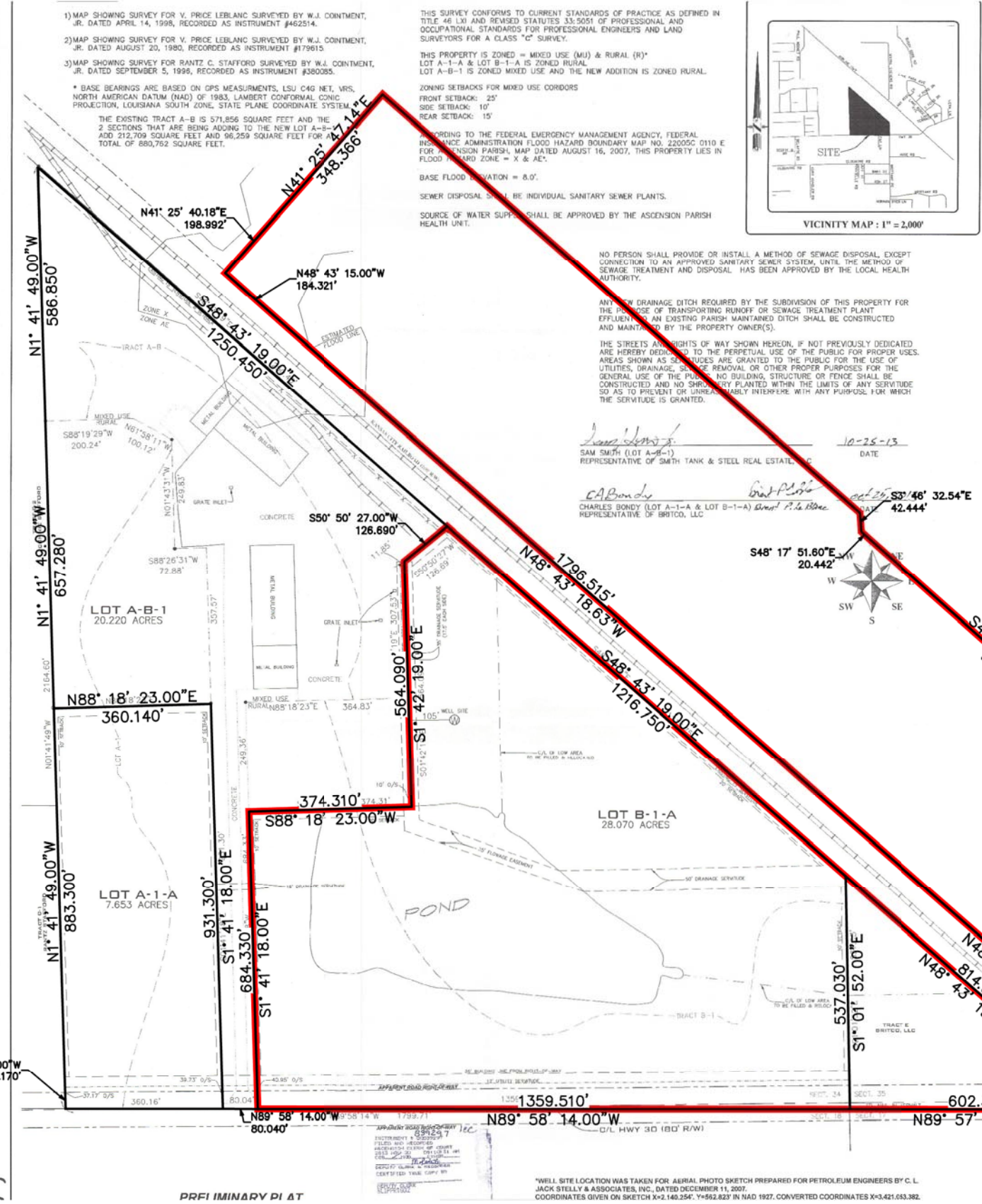


Exhibit E. Britco Site Property Boundary Exhibit
